- **ACCA Accelerate Programme** allows Bachelor of Accounting students, typically in their third or final year, to begin ACCA Stage 3 papers while completing their degree. They can take professional-level exams as if they have already graduated, benefiting from exemptions for the first nine papers.
- **ACCA Accelerated Pathway** enables graduates of accredited Bachelor of Accounting programs to seamlessly transition into ACCA Stage 3 (Strategic Professional level).



 - b) **Two optional papers (choose from four):**
 - Advanced Audit and Assurance (AAA)
 - Advanced Financial Management (AFM)
 - Advanced Taxation (ATX)
 - Advanced Performance Management (APM)

1. Student registration with ACCA will be done on an individual basis online. Assistance and support guides will be provided.
2. Students between 13 and 18 years need consent from a parent/guardian. There'll be a special form required by ACCA to be filled out and returned back. Assistance and support guides will be provided.
3. All study materials will be uploaded into Student Portal: <https://portal.accountancymentor.com>. Students can download all materials from the portal. Only registered students can have access to the Student Portal.
4. Payment for Course Fees can be made via debit card, credit card, or online transfer as per the instructions on the website: <https://www.accountancymentor.com/registration-faqs/>.
5. Course fees paid are strictly nonrefundable and nontransferable.
6. All online sessions will be via Google Meet. Students will only need to access the Student Portal and click the link.

- Teaching assignments cover local and overseas. This includes personal coaching on a 1-on-1 basis to the CEO of an international bank and PDRM on financial crimes.


